ARTICLE 1	To choose a Moderator to preside at said meeting.
ARTICLE 2	To see if the District will vote to accept the reports of the Water Commissioners and the District Treasurer.
ARTICLE 3	To elect one member of the Board of Water Commissioners for a three (3) years term.
ARTICLE 4	To elect a District Treasurer for a three (3) years term.
ARTICLE 5	To elect a District Clerk for a three (3) years term.
ARTICLE 6	To see if the District will vote to raise and appropriate the sum of \$635,376.10 for the Operations Funds of the North Raynham Water District for the fiscal year July 1, 2016 through June 30, 2017 according to the budget or take any action relative thereto.
ARTICLE 7	To see if the District will vote to raise and appropriate the sum of \$412.817.00 for the Wage Funds of the North Raynham Water District for the fiscal year July 1, 2016 through June 30, 2017 according to the budget or take any action relative thereto.
ARTICLE 8	To see if the District will vote to raise and appropriate the sum of \$92,802.50 for the Principal and Interest payment on the Wilbur St. Storage Facility Debt or take any action relative thereto.
ARTICLE 9	To see if the District will vote to raise and appropriate the sum of \$261,338.39 for the Principal and Interest payment on the Arrowhead Filtration Plant Debt or take any action relative thereto.
ARTICLE 10	To see if the District will vote to raise and appropriate the sum of \$15,000.00 for the Reserve Fund or take any action relative thereto.
ARTICLE 11	To see if the District will vote to raise and appropriate the sum of \$15,000.00 for the Emergency Fund or take any action relative thereto.
ARTICLE 12	To see if the District will vote to raise and appropriate the sum of \$1,500.00 for the Tank Inspection and Cleaning Fund or take any action relative thereto.
ARTICLE 13	To see if the District will vote to transfer \$10,000.00 from the (E&D) Free Cash for the Clean Well/Pump Cleaning Fund or take any action relative thereto.
ARTICLE 14	To see if the District will vote to transfer \$25,000.00 from the (E&D) Free Cash for the 141 King Philip Station Improvement Fund or take any action relative thereto.

- ARTICLE 15 To see if the District will vote to transfer \$5,000.00 from the (E&D) Free Cash for the Arrowhead Raw Meter Replacement Fund or take any action relative thereto.
- ARTICLE 16 To see if the District will vote to transfer \$15,000.00 from the (E&D) Free Cash for the Paving fund or take any action relative thereto.
- ARTICLE 17 To see if the District will vote to exempt the balance of Free Cash from the Provisions of Section 12A of Chapter 151 of the Acts of 1979 and that such Free Cash not to be utilized for the purpose of reducing the property tax for Fiscal Year 2016/2017 or take any action relative thereto.
- ARTICLE 18 To see if the District will vote to authorize the District Treasurer, with the approval of the Water Commissioners, to borrow in anticipation of the revenue for the twelve month period beginning July 1, 2016 in accordance with General Laws, Chapter 44, Section 4, and acts in amended thereof, and including in addition thereof, Chapter 849 of the Acts of 1969, as amended and renew any note or notes as they may be given for a period of less than one year in accordance with General Laws, Chapter 44, Section 17.
