GREETING:


In the name of the COMMONWEALTH OF MASSACHUSETTS, you are hereby directed to notify and warn the inhabitants and voters of that part of the TOWN OF RAYNHAM residing in the territory and included within the boundaries of the NORTH RAYNHAM WATER DISTRICT qualified to vote in Elections to meet at the North Raynham Water District Office Located at 80 Baker Road, Raynham, Massachusetts on Wednesday, the 6th of December, Two-Thousand and Seventeen at **Six o'clock P.M.** for the following purpose to wit:

- Article 1            To choose a Moderator to preside at said meeting.
- Article 2            To see if the District will vote to approve the Commissioners acceptance of the bid from Inspec Coating Inc., for **\$492,000.00** with a 10% contingency to paint and repair the Wilbur Street Standpipe located at 2 Wilbur Street, Raynham, Ma or take any action relative thereto.
- Article 3            To see if the District will vote to raise and appropriate or transfer from available funds or borrow the sum of \$541,200.00 for the purpose of Painting the Wilbur Street Standpipe at 2 Wilbur Street, Raynham, Ma including without limitation all costs thereof as defined in Section 1 of Chapter 29C of the General Laws, as amended; and to meet such appropriation, the Treasurer with the approval of the Board of Water Commissioners to borrow the sum of \$541,200.00 under and pursuant to Massachusetts General Law 44, Section (8) (4) or take any action relative thereto.

And you are directed to serve this warrant by posting up attested copies thereof at two or more places in the District at least fourteen (14) days before the time of the meeting.

HEREOF FAIL NOT, and make due return of this Warrant, with your doings thereon to the District Clerk at the time and place of meeting as aforesaid.
